Dear Autumn Landing/Nature's Cove Resident,

KCDC has completed the required baseline Utility Allowance (U/A). As a result, a significant decrease has been calculated based on actual utility costs at Autumn Landing and Nature's Cove, and a request to adjust the U/A has been submitted to the United States Department of Housing and Urban Development (HUD). A reduction in utility allowance amounts will result in an increase in tenant rent. Whenever a decrease exceeds 15% of the most recent utility allowance amount and that decrease is equal to or greater than \$10, the decrease must be phased in. This change will take effect on 04/01/2026.

During a period of 30 days from the date of service of this notice, tenants of Autumn Landing and Nature's Cove may submit written comments on the proposed rent adjustment to us at: Autumn Landing, located at 6331 Pleasant Ridge Road; KCDC's Main Office, located at 901 N. Broadway; and on KCDC's website at <a href="www.kcdc.org">www.kcdc.org</a>. Tenant representatives may assist tenants in preparing those comments. These comments will be transmitted to HUD/CA, along with our evaluation of them and our request for a decrease.

When HUD advises us in writing of the decision on our request, you will be notified. If the request is approved, any allowable adjustment will be put into effect only after a period of at least 30 days from the date you are served with that notice and in accordance with the terms of existing leases.
